OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
OCTOBER 20, 1998

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Bill Cramer, Gordon Johnston, Jim Hutchinson, Cat Urbigkit of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of October 6, 1998, were amended to correct the spelling of "Neher" and "purchased" in paragraph 16 and were ordered filed on motion by Commissioner Johnston and seconded by Commissioner Cramer. The motion carried.

The official bond was approved for Brad M. Radakovich, Treasurer for the Hoback Ranches Service and Improvement District, in the amount of \$5,000, was approved and ordered filed with the County Treasurer.

No bids were received from the advertisement for the plowing of Skyline Drive. The Board took no action, and directed the County Clerk to contact the parties involved in the contract for their input.

It was moved by Commissioner Cramer and seconded by Commissioner Johnston to approve the request from School District #1 for leave for Jim Malkowski and Cathy Saxton to attend the annual Wyoming School Board Convention in Casper on November 18-20, 1998. The motion carried.

The County Clerk presented a budget proposal for the Ag. Center in the amount of \$49,100. The Board directed the Clerk to advertise for the transfer of funds for the proposal at the November 10th meeting.

Stuart Thompson discussed his zoning violations with the Board. Others present were: Jim Bond, Ralph Herbert, Janet Montgomery, Joanne Garnett, Darlene Staley, Jud Faler, and Claire Faler. Thompson presented a historical overview of his business ventures in Sublette County, including Logcrafters and White Pine Ski Area. The Board repeatedly requested Thompson to inform them of his intentions to comply with the injunction, which has been extended to October 21st. The Board agreed to proceed to file default action, with no further extensions. Thompson informed the Board that he would hire an attorney, consult with his partners, and that the action would delay the development of White Pine Ski Area for another year.

Fred Wuthrick, Leanne McClain, and Sally Mackey, representing the Sublette Citizens for Recycling, requested that the Board transfer funds from the Landfill Reserve to them for the purchase of the County Assessor's pickup, which has been traded, in the amount of \$2,100.00. After discussion of other options and the County's current support of the Recycling Program, it was moved by Commissioner Cramer and seconded by Chairman Wassenberg to advertise for the transfer of funds from the Landfill Reserve fund, in the amount of \$2,100.00 for the pickup. The motion carried, with the vote being: Wassenberg-aye, Cramer-aye, and Johnston-nay.

McClain presented Bill Cramer with the Recycler of the Year Award.

Deputy County Attorney Ed Wood advised the Board that he had authorized the expenditure of approximately \$4,000 for the extradition of a prisoner for prosecution for poaching in 1988 in the Big Piney area.

Chairman Wassenberg reported on a meeting with Brad and Dick Waters of Providence Associates, Inc., regarding space and facilities. Wassenberg advised that a written proposal will be available at the November 10th meeting.
