Dew was advised that the Board is not considering moving the Public Health Nurse and Sanitarian to the old Library and is working with a consultant to address its space needs.

The Board reviewed and signed a letter of support prepared by Commissioner Johnston to the Wyoming Chapter of the Foundation for North American Wild Sheep.

Ann Noble and Clint Gilchrist reviewed the activities of the Sublette County Historic Preservation Board and reported that the Board has received its second year of funding. Noble reported on the future CCC Camp project and the Rendezvous Site National Landmark.
