OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
AUGUST 3, 1999

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Gordon Johnston, Betty Fear, Barry Beausoleil of Pacific Power, Cat Urbigkit of the Pinedale Roundup, Rob Shaul of the Sublette County Journal, Mike McGinnis, and Mary Lankford, County Clerk present. Chairman Bill Cramer was not present, and Commissioner Johnston assumed the chair.

The minutes of the special meeting of July 16, 1999, and the budget hearing of July 19, 1999, were ordered filed and the minutes of the preceding regular meeting of July 20, 1999, were amended to change the minutes regarding Commissioner Johnston's comments on the Ag. Center to supporting proper construction of the facility, but not funding the project from the County's funds. It was then moved by Commissioner Fear and seconded by Commissioner Johnston to approve the minutes, as amended, and order them to be filed. The motion carried.

The official bond was approved for Allen Luckow, Secretary Treasurer for the Joint Big Piney Marbleton Volunteer Fire Department, in the amount of \$20,000, was approved and ordered filed with the Fire Board.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to cancel the second September meeting on the 21st, due to the Wyoming Association of County Officers meeting in Sheridan. The motion carried.

Burleigh Binning presented a proposal to seal coat and stripe the asphalt parking lots at the Courthouse and Law Enforcement Building for the amount of \$3,476.00, and to asphalt the parking area in front of the Courthouse for \$8,649.60. It was moved by Commissioner Johnston and seconded by Commissioner Fear to accept the proposal for \$3,476.00 to seal and stripe the existing parking lots. The motion carried.
