

The Board approved a voucher from the County Treasurer for the payment of the Cora Y Mosquito District #3's spraying.

The Board signed the Metro Contracts for 1999-2000 for Marbleton and Big Piney.

A voucher from Carol Rogers was presented for the replacement of her windshield, due to gravel from a County dump truck. It was moved by Commissioner Johnston and seconded by Commissioner Fear to reject the voucher. The motion carried.

The Board approved a request from the Pinedale Fine Arts Council for the use of the old library from November 15-21, 1999, for Black Ties and Blues, and a request from the Pinedale Student Council for the use of the old library on September 16 and 17, 1999, for the Homecoming dance.

In accordance with the public notice published in the Pinedale Roundup on August 26, 1999, public hearing was held for the following:

1. It was moved by Commissioner Johnston and seconded by Commissioner Fear to approve the conditional use permit application by George Archuleta to apply an asphalt surface to a private dirt surface runway on a 732 acre ranch zoned A-1 located in parts of Section 21 and 28, T27N, R112W, with the condition of no commercial or public use of the airstrip permitted. The motion carried.

The Board approved and signed the plat for the Forest Glen Lot Division.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to approve a malt beverage permit for the Pinedale Snow Explorers for a grass drag race in a field west of Pinedale on September 12, 1999, and a malt beverage permit to Lorraine Gatzke on behalf of the EMS Service for the Truck Pulls at the County Fairgrounds on September 11, 1999. The motion carried.

Peggy Noble, Chairman of The Learning Center Board of Directors, presented the Board with the 1999 Employer-Business of the Year Award from the Wyoming Early Childhood Association. Representatives from The Pinedale and Big Piney Learning Center and children and staff of The Pinedale Preschool were present for the award presentation.

Ken Konicek of Tegeler and Associates, discussed the County's health insurance renewal. It was moved by Commissioner Johnston and seconded by Commissioner Fear to renew the coverage, adjust the specific stop loss deductible from \$17,500 to \$22,500, and leave the employee contributions the same. The motion carried. The Board directed that a review of the insurance program begin in January.

At the request of the Library Board, it was moved by Commissioner Johnston and seconded by Commissioner Fear to approve a request for an early advance of \$80,000 from the County General Fund for the County Library Board. The motion carried.

Julie Early discussed rabies with the Board, and suggested establishing a control district. The Board referred Early to the Sheriff and the County Health Officer to prepare a resolution.

After viewing the parking lot next to the Extension Service, the Board directed McGinnis to prepare a repair proposal.

John McKinley of Davis and Cannon, discussed the Supreme Court decision on the Exxon appeal and reported that he had invited Exxon, through its attorney, Brent Kunz, to discussion resolution of the "old years".

The Board closed the meeting for an Executive Session with John McKinley of Davis and Cannon.

The Board reopened the meeting.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to accept and sign the Agreement/Lease with School District #1 for the skateboard park. The motion carried.
