

The meeting reconvened.

The County Clerk reviewed the proposed insurance coverage for the volunteer firemen, and the Board approved pursuing the coverage, and directed the County Clerk to discuss the details of securing the coverage with the Fire Board.

The following requests for use of the Old Library were approved:

1. November 4, 1999, School District #1
2. December 9, 10, & 11, 1999, Pinedale Area Chamber of Commerce

Sheriff Hank Ruland and Undersheriff Henry Schmidt reported on possible loss of funding to the Law Enforcement Academy, search and rescue, and the detention center food program with Sublette Hi Country Senior Citizens. Schmidt reported on an effort to secure a snowmobile for use with the rescue sled, and informed the Board that Search and Rescue with donate half the cost of the purchase of a used snowmobile. The Board approved the purchase of half of the snowmobile from search and rescue funds. Ruland reported that he will inform the State of Wyoming that Sublette County will not support the State's snowmobile trail patrol program.

In accordance with the public notice published in the Pinedale Roundup on September 23, 1999, public hearing was held for the following:

1. It was moved by Commissioner Fear and seconded by Commissioner Johnston to accept and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried, and the following resolution was adopted:

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF BILLY AND ANNIE PAPE TO RECLASSIFY AND REZONE 5 ACRES, MORE OR LESS, FROM A-1 DISTRICT TO R-R 5 DISTRICT, BEING PART OF THE SE1/4 OF SECTION 3, T33N, R109W.

2. The Board signed the Mike Irwin Lot Division plat.

Billy Pape discussed his property assessment and taxes with the Board and County Assessor Janet Montgomery. The Board directed the County Assessor to prepare an abatement for the Board's consideration.

No action was taken on the award of a bid for the snowplowing on Skyline Drive.

The Board directed the County Clerk to invite Scott Thompson, Emergency Management Coordinator, to the next meeting.

The Board met with the Elected Officials and Department Heads. County Attorney Dale Aronson reported on his meeting with the Fair Board and its next meeting on October 27th. The Board discussed a bidding procedure and informed those present that a written proposal will be circulated for their consideration. County Assessor Janet Montgomery reported that the new doors were installed at the Walker Building. County Clerk Mary Lankford reported on the draft report from Brad Waters, space consultant.

The following petitions and affidavits of abatements of taxes were presented on petition from the County Assessor and the State Board of Equalization: Celsius Energy Company, \$456.65, and Milt B. & Cynthia J. Friel, Jimmy Cash Grimes, Larry P. & Kathy Ivie, and Robert S. McCarty, Jr., \$25.00 each.

The Board closed the meeting for a conference call in Executive Session with John McKinley and Nancy Freudenthal of Davis and Cannon regarding litigation.
