OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
DECEMBER 7, 1999

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Cat Urbigkit of the Pinedale Roundup, Rob Shaul of the Sublette County Journal, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of November 16, 1999, were ordered filed on motion by Commissioner Fear and seconded by Commissioner Johnston. The motion carried.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to adopt Resolution No. 99-631C declaring the Cramer-Jones Alteration of the Big Sandy-Elkhorn County Road No. 23-118 the true location of the County Road, that the State of Wyoming No. 4257 easement be relinquished and extinguished upon the recordation of State of Wyoming No. 5944 easement, and direct the County Surveyor to depict said alteration upon Sheet 2 of the official plat for said Big Sandy-Elkhorn County Road No. 23-118. The motion carried.

Paul Scherbel presented a proposal for the alteration of the subdivision roads in Highland View Estates Second Subdivision. The Board directed Scherbel to draft a letter to be sent to the subdivision property owners.

Len Wooley of the Wyoming Business Council, discussed the efforts of the Wyoming Business Council and economic development in Southwest Wyoming. Wooley will be arranging presentations, in the future, with the County and the Towns.

In accordance with W.S. 22-29-109(c), public hearing was held for the proposed enlargement of the Shelter Park Improvement District. Dave Swank represented the petition for enlargement. No comments were received from the public.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to deny a voucher submitted by Casey Quintard for the replacement of two windshields. The motion carried.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to adopt Resolution No. 99-632C supporting Cooperating Counties' Environmental Impact Statement Revised Alternative "E" for the Winter Use and Environmental Impact Statement for the Yellowstone and Grand Teton National Parks. The motion carried.

Laurie Latta, Jo Crandall, Gayle Kinnison, and Wendy Walter discussed the use of the Old Library as a community center, reviewed the activities that have been held there, and requested consideration by the Board to allow the facility to continue to be used by the public. The Board informed the group that it is currently in the process of studying space needs for County departments and that the Old Library is part of that study.

Gary Wilson, representing the EMS, requested use of the key pumps at the County Shop for fuel for the ambulances. The Board tabled the discussion until December 21st, when Mike McGinnis, Road and Bridge Superintendent is present.

The Board approved a request for the use of the Old Library for a benefit on December 19, 1999, for Lynette Heathman.

It was moved by Commissioner Cramer and seconded by Commissioner Johnston to adopt Resolution No. 99-634C recognizing the significance of December 7th, and acknowledging and thanking those men and women, who by their efforts, sacrifices, honor, and integrity provided and continue to provide the peace and freedom that we quietly experience each and every day, and may it continue and prevail in the new millennium. The motion carried.
