

00.008.1 OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
00 51 JANUARY 18, 2000

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Cat Urbigkit of the Pinedale Roundup, Rob Shaul of the Sublette County Journal, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of January 10, 2000, were ordered filed on motion by Commissioner Johnston and seconded by Commissioner Fear. The motion carried.

The official bonds for Alice Griggs, Clerk Treasurer for the Town of Marbleton, in the amount of \$50,000; Brad Radakovich, Treasurer for the Hoback Ranches Service & Improvement District, in the amount of \$5,000; William M. Barney, Treasurer for Sublette County Mosquito Abatement District #2, in the amount of \$25,000; Karla Holloway, Treasurer for the Sublette County Fair Board, in the amount of \$2,000; were approved and ordered filed with the County Treasurer.

Mike McGinnis, Road and Bridge Superintendent, reported that the Emergency Management vehicles have been stored at the County Shops, and on the activities of the Pinedale Anticline Transportation Committee.

Commissioner Johnston reviewed a draft letter he had prepared, in support of a location adjacent to the Industrial Site for the Pinedale Sporting Clays Shooting Sports Complex. The County Clerk was directed to send the letter to the BLM.

The Board discussed the poor condition of Skyline Drive, the lack of plowing of the parking areas, and the status of continued participation in a cooperative agreement by the remaining cooperators without the Forest Service. The Board discussed the status of the injunction and the lack of application by Stuart Thompson for a conditional use permit, as agreed to at the December 20th special meeting. Public safety and lack of recreational opportunities was discussed. Later in the day, and after discussing the situation with Mark Reneau, it was moved by Chairman Cramer and seconded by Commissioner Fear to authorize Mike McGinnis to supervise the contractor in the plowing of Skyline Drive and three parking areas, as in the past, for the remainder of the winter season. The motion carried. The Board then hired Reneau, at his bid price from October, and directed McGinnis to start on the plowing. McGinnis informed the Board that Reneau would start that evening.

Lance Koppenhafer, Chairman of the Ag. Center Committee, informed the Board that the Committee had met, and its next meeting will be February 1st at the Fairgrounds. Kent Keller will be serving as secretary and John Copeland will serve as treasurer.

Todd Perry of Proactive Rehabilitation, discussed a transportation problem of one of his clients with the Board. The Board referred him to the County Attorney and the Hi Country Senior Citizens Board of Directors.

Commissioner Johnston reported that the CCC Pond project has been completed and the Committee has disband. Johnston informed the Board that a kiosk will be built, and the Board should be thinking of information for it.

The Board decided to hold its February 15th meeting at the Marbleton County Annex.

In accordance with the public notice published in the Pinedale Roundup on December 23, 1999, public hearing was held for the following:

1. It was moved by Commissioner Johnston and seconded by Commissioner Fear to approve and sign the plat for the Homestead Large Tract Development, consisting of 7 tracts of 40 acres, more or less, zoned A-1, located in parts of Sections 14 and 15, T35N, R113W. The motion carried.

2. The Board signed the Bloom Lot Division plat, which was previously approved.

Planning and Zoning Commission Chairman Jim Bond presented the list of Sublette County Citizens, with recommendations for the Comprehensive Plan Update Steering Committee and Focus Groups. The Board reviewed the list and thanked the Commission for its work on this project. It was moved by Commissioner Fear and seconded by Commissioner Johnston to appoint the following people:
