Bob Bezak and Scott Thompson, representing Emergency Management, discussed Emergency Management. The Board advised Thompson to discuss obtaining an old Law Enforcement vehicle from the Sheriff's Department for his use, instead of a surplus vehicle. It was moved by Commissioner Fear and seconded by Commissioner Johnston to authorize Chairman Cramer to sign the Annual Assurances and Soft Match Authorization for Sublette County Emergency Management. The motion carried, and the documents were signed.

Commissioner Johnston reported on the Green River Valley Cattlemen's Association meeting and cooperating agency status.

The Board reviewed a letter from the Pinedale Airport Board, and requested the County Clerk to obtain current information on the information provided.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to adopt Resolution No. 00-641C supporting the withdrawal of the Thunder Basin Grasslands DEIS. The motion carried.

It was moved by Commissioner Fear and seconded by Chairman Cramer to approve Change Order #3 in the amount of \$4,804.00. The motion carried, with the vote being: Cramer-aye, Fear-aye, and Johnston-abstaining.

After lengthy discussion, it was moved by Commissioner Johnston and seconded by Chairman Cramer to request "Eligible Entity" status for the Community Service Block Grant program. The motion carried, with the vote being: Cramer-aye, Johnston-aye, and Fear-abstaining.
