

A request for the use of the Old Library for vacation bible school on July 24, 25, and 26, 2000, for the Pinedale Church of Christ was approved.

The Board accepted a request from the Big Piney Airport Board, subject to final approval, for \$44,000.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to approve and sign the East Meadow Lot Division plat. The motion carried, and the plat was signed.

In accordance with the public notice published in the Pinedale Roundup on May 25, June 1, 8, & 15, 2000, public hearing was held for the transfer of the retail liquor license at The Place. Clark Corbridge, representing the Reints Family, LLC, informed the Board that his client is foreclosing on SMC Wireless, Inc., the current owners. County Attorney Aronson advised the Board that Reints' do not, currently, own the property and are unable to obtain approval for the transfer of the license from SMC Wireless, Inc. After discussion of the situation, it was moved by Commissioner Johnston and seconded by Commissioner Fear to table the transfer. The motion carried.

County Attorney Aronson discussed the proposed contract with Brad Waters for the Courthouse Renovation project, and the Board directed Aronson to continue negotiating with Waters.

Gary and Nancy Espenscheid discussed the "punch list" for the completion of the Ag. Center and some items that were omitted. The Board designated Gary Espenscheid to act as agent for the County to discuss the items with the contractor and architect. County Clerk Mary Lankford reported that the publication for the final payment has been delayed one week, due to late receipt of the notice from the architect. Chairman Cramer informed the Espenscheids that the Board had toured the facility and grounds and have directed the Road & Bridge Department to meet with them and a representative of the Fair Board to prepare road work around the facility by July 4th. Chairman Cramer requested a list of in-kind donors. Liquidated damages were discussed, due to the building not being complete, causing three scheduled events to be canceled. It was moved by Commissioner Johnston and seconded by Commissioner Fear to approve Change Order #5, which was a \$3,000 decrease for volunteer work. The motion carried. The fire suppression system and Fire Marshall inspection was discussed. The Board delayed action on Change Order #6 and the Certificate of Substantial Completion.

Representative Louie Tomassi welcomed the Board to Marbleton and thanked it for meeting there.
