

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
JULY 18, 2000

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Cat Urbigkit of the Pinedale Roundup, Rob Shaul of the Sublette County Journal, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meetings of June 30, and July 3, 2000, were ordered filed on motion by Commissioner Johnston and seconded by Commissioner Fear. The motion carried.

The official bonds were approved for Peggy Winters, Treasurer for the Sublette County Mosquito Abatement District #1, in the amount of \$1,000; Allen Luckow, Secretary-Treasurer for the Joint Big Piney Marbleton Volunteer Fire Department, in the amount of \$20,000; and Peter Arambel, Secretary Treasurer for the Predatory Board, in the amount of \$1,000, were approved and ordered filed with the County Treasurer.

A resolution for partial closure of Hoback Ranches Subdivision due to extreme fire danger was presented by County Fire Warden John Blaha. The Board signed Resolution No. 00-658C, which was approved at the July 3rd meeting.

Mike McGinnis, Road and Bridge Superintendent, reported that the crusher has moved to the Red Castle pit, that gravel is being hauled for the Fish Creek and Middle Piney roads, and that he will be meeting with HK Contractors about the Cora and Ryegrass projects. McGinnis informed the Board of radio interference and the need for a new building at the Hogsback for the county's repeater. Landfill charges were discussed, and the Board decided to use the "common sense" approach of charging. It was reported that the machine used to lay the new cover material at the Marbleton Landfill won't work and is scheduled for repair. The new fencing at the Marbleton Landfill is scheduled to be complete by the end of August.

Traffic signage was discussed for Muddy Speedway County Road No. 23-113 and East Fork Big Sandy County Road No. 23-133.

The Board discussed the purchase of side scanning solar equipment for search and rescue with Undersheriff Henry Schmidt. Cost sharing with other western Wyoming counties and the state were discussed.

The Board reviewed the Final Budget Summary, the Appropriation Resolution, and the Resolution To Provide Income Necessary to Finance the Budget. It was moved by Commissioner Fear and seconded by Commissioner Johnston to adopt the FY01 Appropriation Resolution. The motion carried. It was moved by Commissioner Johnston and seconded by Commissioner Fear to adopt the FY01 Resolution To Provide Income Necessary To Finance the Budget. The motion carried. The resolutions were signed by all members of the Board.

revised and altered, be adopted as the official
county budget for the fiscal year ending June 30, 2001.

BE IT FURTHER RESOLVED, that the following
appropriations be made for the 00-01 fiscal year
ending June 30, 2001 and that the expenditures of
each officer, department or spending agency be
limited to the amount herein appropriated.
