OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
APRIL 3, 2001

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Bill Cramer, Betty Fear, Cat Urbigkit of the Sublette Examiner, Rob Shaul of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present. Commissioner Gordon Johnston was absent.

The minutes of the preceding meeting of March 20, 2001, were approved and ordered filed on motion by Chairman Cramer and seconded by Commissioner Fear. The motion carried.

The official bond for Paul N. Scherbel, County Surveyor, in the amount of \$1,000 was approved and ordered filed with the County Clerk.

Bob Maxam, Resident Engineer for the Wyoming Department of Transportation, presented an agreement for the production of chips for the Ryegrass and Merna projects. The Board signed the agreement. Maxam reported on the current and summer projects in Sublette County.

Dave Andersen and Slim Perry, of Hogan and Associates, reported on the progress on the Old Library and Courthouse Renovation. A project review meeting is tentatively scheduled for April 16th, and then with the Board on April 17th.

Henry Schmidt, Undersheriff, presented a contract with the Wyoming Department of Health for a grant of \$3,000 for tobacco products education. The Board signed the contract. Schmidt presented a request from Ernie Kawa, Communications Officer, to pay half of his retirement buyback. The Board denied the request.

Mike McGinnis, Road & Bridge Superintendent, reported that the bid information will be advertised for the Ryegrass and Merna projects this month, with the bid opening scheduled for the May 1st meeting. It is estimated that the project cost approximately
