

\$307,500. McGinnis reported that roads are being bladed, and that materials are being obtained from WDOT for the East Green River Road. It was reported that the Marbleton Landfill permitting is progressing and that a new work crew is employed at the Landfill. McGinnis reported on the Pinedale Anticline meeting.

John Jackson, of the Wyoming Water Development Commission, discussed the seepage at the Lee Ditch and possible funding. Mayor Rose Skinner reported that the DEQ is not willing to issue a permit for temporary use of the Shelter Park sewer line for disposal of the water. Diverting the water to Pine Creek was discussed. Daryle Bennett, of the Natural Resource Conservation Service, discussed costs and alternatives.

Mark Eatinger, Ed Wood, and Mike Irwin discussed a corrective easement at the Pinedale Airport property to allow access by Irwin for development of his property. The Board approved the request, and Wood will prepare the easement for the Board's consideration.

Tommy Thompson, representing the Pinedale Sporting Clays Association, requested extension of the County road which accesses the Sporting Clays range. The Board authorized the construction of a roadway with an 18-20 foot running surface for approximately one-half mile.

The Board recessed the meeting to tour roads which were treated with a soy product last year for soil stabilization.

The Board signed a lease with Few Investments, LLC, for office space in the Mortenson and Stevens building for 10 years at \$940 per month.

It was moved by Commissioner Fear and seconded by Chairman Cramer to purchase property and casualty insurance for the County from Tegeler and Associates with NIPC/Diamond State Insurance Company for an annual premium of \$104,803. The motion carried.

The Board directed the County Clerk to solicit proposals from life and health insurance consultants for possible bidding.

The Board approved a request from the Pinedale Area Chamber of Commerce for use of the skating rink for Rendezvous weekend.

The Board directed the County Clerk to contact Mike Quinn, Ag. Center architect, concerning the fire suppression system.
