

OFFICIAL COUNTY COMMISSIONER PROCEEDINGS
JUNE 6, 2001

The Board of County Commissioners met as the County Board of Equalization on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Jennifer Binning of the Pinedale Roundup, Janet Montgomery, County Assessor, and Mary Lankford, County Clerk present.

The County Board of Equalization recessed and acted as the Board of County Commissioners to consider the following petitions and affidavits of abatement of taxes as presented on petition from the County Assessor and the State of Wyoming Board of Equalization: George (Chopper) Grassell, \$5,430.66; EOG Resources, \$162,456.09; Exxon Corporation, \$2,385.32; and Boroff Land & Livestock, Inc., \$13,892 (Assessed Value).

The Board recessed as the Board of County Commissioners and reconvened as the County Board of Equalization to consider the following petitions of contested valuation:

1. The Board met with Jud and Claire Faler, and Betsy Greenwood, to assure the reduction in value to their property due to the detrimental use across the road from their property. The Board took no action, and the reduction will stand.

2. Michial Val Kaplan, 160 acres located in the SW1/4NE1/4, SE1/4NW1/4, NW1/4SE1/4, NE1/4SW1/4, Section 16, T39N, R110W. Dona Rae Morss represented the petition and discussed the agricultural use of the property. No income is derived from the property. The hay produced supports the horses, which do not leave the property. It was moved by Commissioner Johnston and seconded by Commissioner Fear to grant agricultural value.

The motion carried.

The Board recessed as the County Board of Equalization and will tentatively reconvene on July 17, 2001, to consider a petition of contested valuation from Questar. The Board convened as the Board of County Commissioners, in special session, to continue preparation of the FY02 budget, at 11:00 a.m.
