The Board approved and signed the Riggs Lot Division and Stevie Lot Division plats.

The Board received a budget request from the Southwest Sublette Pioneers for \$31,500.00, subject to final approval.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to award the County Commissioners Renewal Scholarship to Kristin Schaefer, with Candace Callison, first alternate, and Jenny Mackey, second alternate. The motion carried.

Sheriff Hank Ruland and Undersheriff Henry Schmidt presented a proposed salary schedule for their department, discussed Earth First, and discussed possible oil field law enforcement officers. The Board requested speed enforcement on Madison Avenue and Stone Trail. The Board denied a request to waive the vacation use policy.

The Board received a budget request from John Fear and Lance Koppenhafer, representing the Ag. Center Committee for \$89,075.00, subject to final approval.

The Board recessed the meeting into Executive Session for a conference call with John McKinley and Nancy Freudenthal of Davis and Cannon, to discuss ongoing litigation.

The Board reconvened the meeting.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to issue a malt beverage permit to Moose Productions for the Wind River Blues Festival on June 23, 2001, at the Pinedale Rodeo grounds. The motion carried.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to issue a malt beverage permit to the Sublette County Sporting Association for July 12, 13, and 14, 2001, for the Rendezvous Rodeos at the Pinedale Rodeo grounds. The motion carried.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to approve and sign a Letter of Engagement with Mortenson, Stevens & Company, PC, for \$21,400.00 for the FY01 financial audit. The motion carried.

The Board received a budget request from the Sublette County Fair Board for \$168,800.00, subject to final approval.

The Board discussed the inactivity of the Cora Y Mosquito Abatement District. The County Clerk was directed to contact the district concerning its future.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to renew the malt beverage permit for Wind River Resorts, Inc. dba White Pine Ski Area and Resort. The motion carried.

It was moved by Chairman Cramer and seconded by Commissioner Johnston to appoint the following people to the Lodging Tax Joint Powers Board: Aaron Gesch, one-year term; Leanne McClain-Rellstab, two-year term; and Lisa Doorn, three-year term. The motion carried.

The Board discussed insurance coverage for properties with County-funded buildings and/or equipment. The Board decided to require property lease or ownership, before extending County insurance coverage.
