

Bubba Larsen complained to the Board about Planning and Zoning Commission member John Dahlke's conduct at a recent Planning and Zoning meeting. A letter, received by Chairman Cramer, from Gary Creason, was read. The Board advised Larsen that it would consider his complaint when future appointments are made to the Commission.

Missy McAmis and Mark Eatinger discussed a 100 foot easement on the north boundary of the McAmis Lot Division and the Westfall (Cora) Cemetery. McAmis requested the Board to consider abandoning the easement on the north boundary of Tract 2 of the lot division and reducing the width, the entire length of the easement to 60 feet. The Board agreed to abandon the easement on Tract 2, and advised McAmis and Eatinger to prepare the proper notice.

Ed Wood discussed errors in Resolution No. 01-691C, which vacated and abandoned easements held by Sublette County across lands owned by Christmann Corporation. It was moved by Commissioner Fear and seconded by Commissioner Johnston to adopt Resolution No. 91-701C reforming and amending Resolution No. 01-691C. The motion carried.

Dave Andersen and Slim Perry of Hogan and Associates, presented the bids for subcontracted work for the remodel of the Old Library. It was moved by Commissioner Johnston and seconded by Commissioner Fear to rebid the electrical portion of the project and award the following bids: Vaughn's Plumbing and Heating, \$163,489.00; Cannon Sales, \$2,184.00; Brown's Drywall, \$60,042.56; Hegemann Painting, \$12,300.00; Fairway Tile & Marble, \$9,880.00; Comflors, Inc., \$15,541.00; Architectural Building Supply, \$22,798.00; O'Brien Glass, \$15,751.53; Tabor Insulation, \$11,651.00; Salt River Roofing, \$53,775.00; and TMC Builders, \$38,185.00. The motion carried. It was decided to require bonding for the electrical and mechanical portions of the project.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to issue a malt beverage permit to the Pinedale Lions Club for the Rendezvous BBQ at the Rendezvous Grounds on July 14, 2001. The motion carried.

The Board scheduled a budget work session for Thursday, July 5, 2001, at 1 p.m.

County Clerk Mary Lankford informed the Board that County Fire Warden John Blaha has approved a request from Hoback Ranches for a partial fire closure within the subdivision, due to extremely dry conditions, and recommends that the Board adopt a resolution imposing the closure. It was moved by Commissioner Fear and seconded by Commissioner Johnston to accept the recommendation of the County Fire Warden and the Fire Board and impose a partial closure of Hoback Ranches Subdivision, due to extreme fire danger. The motion carried.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to waive the Temporary Merchant's fee for the upcoming Rendezvous Weekend of July 13, 14, & 15, 2001. The motion carried.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to adopt Resolution No. 01-700C declaring Sublette County an agri-business disaster area. The motion carried.

Upon the recommendation of Dale W. Cottam of Hirst and Applegate, Attorneys at Law, the Board approved a stipulation requiring the elimination of the rate disparity in five years, or by December 31, 2005, in the PacifiCorp Rate Case. The motion carried.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to re-appoint Suzy Michnevich for a three-year term to the Planning and Zoning Commission. The motion carried. It was noted that no letters were received for various other boards.

The Board directed Mike McGinnis, Road and Bridge Superintendent, to install a culvert at the access to the Ludwig Lot Division.

Bill Kellen commented on the Recreation Board's request for \$65,000 for a recreation study. Kellen discussed the Kendell proposal for a Boys and Girls Club. Kellen expressed his interest in donating property south of the Entertainment Center for such a proposal.

Sheriff Hank Ruland and Undersheriff Henry Schmidt updated the Board on Earth First and and Jonah Field. Ruland discussed speed enforcement on Madison Avenue, Stone Trail, and the East Green River County Road No. 23-110.

The following petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Gary O. Neely, \$202.78; Wexpro Company, \$77.52; Wexpro Company, \$401.15; and Western Gas Resources, Inc., \$59,971.31.

The Chairman signed the Cooperative Agreement for the receipt and distribution of payments for child support with the Wyoming Department of Family Services and the Sublette County Clerk of District Court.
