

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
SEPTEMBER 14, 2001

The Board of County Commissioners met in Special Session on this date at 9:10 a.m. Betty Fear, Mike McGinnis, Cat Urbigkit of the Sublette Examiner, and Mary Lankford, County Clerk present. The purpose of the Special Session was to open sealed bids for the repair of the Dell Creek and Jack Creek Road Slides. Four sealed bids were opened and referred to Mike McGinnis for recommendation.

Commissioner Gordon Johnston arrived and assumed the chair.

In accordance with the public notice published in the Pinedale Roundup on September 13, 2001, public hearing was held for the following:

1. The Yoast variance request was withdrawn by the applicant.
2. It was moved by Commissioner Fear and seconded by Commissioner Johnston to approve and sign the final plat for Broken Hills Subdivision. The motion carried and the plat was signed.
3. Leslie Schwabacher presented and read into the record a letter of opposition to the final plat. It was moved by Commissioner Fear and seconded by Commissioner Johnston to approve and sign the final plat for Sand Springs Draw Industrial Park. The motion carried and the plat was signed.

Chairman Bill Cramer arrived, and Commissioner Johnston relinquished the chair.

McGinnis presented a recommendation on the Dell Creek and Jack Creek Road projects. It was moved by Commissioner Johnston and seconded by Commissioner Fear to award both projects. The motion carried.

It was moved by Commissioner Johnston and seconded by Chairman Cramer to accept the low bid of \$216,834.75 from R.S. Bennett Construction Company and authorize McGinnis to award the bid upon final review by Nelson Engineering. The motion carried, with the vote being: Cramer-aye, Johnston-aye, Fear-no vote, conflict of interest.

There being no further business, the meeting was adjourned at 10:15 a.m.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
OCTOBER 2, 2001

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Cat Urbigkit of the Sublette Examiner, Rob Shaul of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of September 4, 2001, and special meeting of September 14, 2001, were approved and ordered filed on motion by Commissioner Johnston and seconded by Commissioner Fear. The motion carried.

Don Wright, Big Sandy Ranch manager, discussed the deteriorating condition of the Big Sandy-Elkhorn County Road No. 23-118. Wright stated that he had contacted eight of the road users and that they are in agreement that the gravel needs to be removed from the road. After discussion, the Board directed McGinnis to remove the gravel and consider alternatives to improve the condition of the road. The Board requested that Wright keep the Board informed about the road.

Beth Rogers thanked the Board for the Road and Bridge's work on Lake Road and inquired when Favazzo County Road No. 23-199 would be graded, due to its rough condition. Rogers inquired about a neighbors approach.

Mike McGinnis, Road and Bridge Superintendent, reported on soil stabilization projects, and the need for a new cell at the Marbleton Landfill. The Board approved McGinnis' request to request proposals from several area contractors for the excavation of a new cell. The Board discussed a letter for Teton County School District #1 requesting reduced rates for disposal of demolition materials. The Board affirmed a rate of \$25 per ton for the material. McGinnis discussed a proposed loader trade-in.

Sheriff Hank Ruland and Undersheriff Henry Schmidt presented a contract for juvenile detention for the Board's consideration. It was moved by Commissioner Johnston and seconded by Commissioner Fear to contract with Frontier Corrections Systems, Inc. for juvenile detention services. The motion carried. It was moved by Commissioner Fear and seconded by Commissioner Johnston to approve and sign a lease agreement with Pape
