OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
 OCTOBER 16, 2001

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Cat Urbigkit of the Sublette Examiner, Rob Shaul of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of October 2, 2001, were approved and ordered filed on motion by Commissioner Johnston and seconded by Commissioner Fear, with the following amendment: Paragraph 9, sentence 2: The motion carried, with the vote being: Johnston-aye, Fear-aye, and Cramer-nay. The motion carried.

The official bonds were approved for Paul C. Hagenstein, Treasurer for the Sublette County Museum Board, in the amount of \$1,500; Bernard Holz, Treasurer for the Sublette County Board of Cooperative Educational Services, in the amount of \$25,000; and Lynne Myers, Bookkeeper for the Recreation Board, in the amount of \$5,000, were approved and ordered filed with the County Treasurer.

Commissioner Johnston reported that the Daniel-Merna County Road is in great condition.

Doug Sterck discussed a proposed easement which would provide a more direct route to the Industrial Site over property he owns. Sterck reported that he has initiated discussions with the Army Corps of Engineers about the required 404 permit through the wetlands and has contracted an environmental group to provide wetland delineation. Sterck requested the Board provide a legal description of the proposed easement, one access to the new road to his property, fencing and soil suppression. The Board referred Sterck to the County Attorney to prepare the easement for the Board's next meeting.
