

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
DECEMBER 18, 2001

The Board of County Commissioners met in regular session in the Marbleton Annex in Marbleton, Wyoming, on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Cat Urbigkit of the Sublette Examiner, Rob Shaul of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of December 4, 2001, were ordered filed on motion by Commissioner Johnston and seconded by Commissioner Fear. The motion carried.

The official bonds for June Wassenberg, Treasurer for the Big Piney Cemetery District, in the amount of \$2,000; Alice Griggs, Clerk Treasurer for the Town of Marbleton, in the amount of \$50,000; Alice Griggs, Clerk for the Big Piney Cemetery District, in the amount of \$2,000; Karla Holloway, Treasurer for the Sublette County Fair Board, in the amount of \$2,000; Kristel Blair, Treasurer for the Meadow Canyon Homeowners Association, Ann Fear, Treasurer for School District #1, in the amount of \$25,000; Curt Parsons, Treasurer for the School District #9 BOCES Board, in the amount of \$50,000; Bill Krieger, Chairman for the School District #9 BOCES Board, in the amount of \$50,000; W. David Burnett, Clerk for the School District #9 BOCES Board, in the amount of \$50,000; B. Weldon Shelley, Director for the School District #9 BOCES Board, in the amount of \$50,000; and Robert Beiermann, Vice Chairman for the School District #9 BOCES Board, in the amount of \$50,000; were approved and ordered filed with the County Treasurer.

Paul Scherbel discussed the naming of Chris Lake, the Sand Draw Industrial Site corners, the Erramouspe easement, and Willow Lake County Road No. 23-120 county easements.

Mike McGinnis, Road and Bridge Superintendent, reported on crushing at the Guio Pit and that the snow plowing crew has been split to provide weekend coverage.

It was moved by Commissioner Johnston and seconded by Chairman Cramer to accept and authorize the Chairman to sign the Certificate of Substantial Completion on the Jack Creek Slide project for R.S. Bennett. The motion carried with the vote being: Cramer-aye, Johnston-aye, and Fear-abstained.

The Board accepted a proposal from Gene Paul Pearson for heating for the Bondurant Shop in the amount of \$1,450.00.

McGinnis reported that the applications are submitted to the Wyoming Department of Transportation and BLM for the proposed relocation of the Industrial Site Road.

The Board discussed the metal received at the Marbleton Landfill and investigating the possible use of a baler at the Landfill.

The Board decided to provide snow removal for the three cross country parking areas along Skyline Drive. The removal will be performed by Road and Bridge with Reneau Construction as an alternate. Jim Meiring of the Recreation Board expressed the Recreation Board's support for the plowing.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to approve and authorize the Chairman to sign an application to patent the Big Piney Gun Club. The motion carried, and the Chairman signed the application.

The Board discussed County Road names and decided to take no action at this time.

The Board directed the County Clerk to notify Garry Eiden about renegotiating the Pinedale Transfer Station contract, if Eiden still requires additional funds for metal disposal.

Gene Defoe inquired about a bill for communications equipment. The Board assured Defoe that it would pay the bill.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to designate Community First National Bank of Big Piney as a depository for public funds. The motion carried.

Chairman Cramer volunteered to attend the BLM Gateway Community Workshop.

Dan Budd and Rep. Louie Tomassi discussed the draft of a Joint Powers Agreement between Carbon, Lincoln, Uinta, and Sweetwater Counties to obtain funding from the Wyoming Water Development Commission to water storage in the Green River Basin. The Board informed them that it has contacted the other four counties for concurrence and will be proceeding the draft agreement in January.

Tomassi discussed the proposed redistricting plan with the Board. It was moved by Commissioner Fear and seconded by Commissioner Johnston to urge the Joint Corporations Committee to consider leaving Sublette County whole in the redistricting plan. The motion carried.

Tomassi requested that the Board consider plowing all of Skyline Drive.

The Board presented checks in the amount of \$143,879.07 and \$2,618.65 to Scott Houfek, Chairman of the School District #9 Board from the Wexpro settlement.
