OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
MARCH 19, 2002

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Cat Urbigkit of the Sublette Examiner, Rob Shaul of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of March 5, 2002, were ordered filed on motion by Commissioner Johnston and seconded by Commissioner Fear. The motion carried.

William Belveal presented a petition to extend New Fork Willow Creek County Road No. 23-120. The petition was reviewed by County Attorney Dale Aronson and revised. The Board discussed the petitioners' deposit and possible disinterested viewers. It was moved by Commissioner Fear and seconded by Commissioner Johnston to authorize the County Clerk to contact Nelson Engineering and appoint the firm as viewer, pending acceptance by the firm. The motion carried. The petition was held for review by the County Clerk for compliance. The Board will notify Blatt of the petition.

Commissioner Fear reported that the meeting for the proposed five county joint powers board for water development is scheduled at the Sweetwater County Courthouse in Green River on April 18th.

John Pierre Erramouspe delivered a letter from Karen Budd-Falen to the Board for consideration.

Professor Tom Clark, Jason Willmont, Lynn Munno, Karen Murry, Greg McLoughlin, and Dylan Taylor, all of Yale University and natural resource management students, discussed the presence of large carnivores in Sublette County in the Bridger-Teton National Forest. The Board discussed working relationships with Federal Agencies, multiple use, wildlife management, and Federal regulations and directives.

Terry Pollard, Todd Stevie, and Kim Bright, representing the Sublette County Outfitters Association discussed the Forest Service Food Storage Order, which is effective on April 1, 2002. The recent opposition actions taken by Fremont and Lincoln Counties on the proposed reintroduction of grizzly bears and wolves was discussed. Pollard reported that it would cost his business \$15,000-\$20,000 to comply with the Food Storage Order, and that the Order also applies to horse feed. It was moved by Commissioner Fear and seconded by Commissioner Johnston to adopt Resolution No. 02-720C requesting the Forest Service to rescind the Food Storage Order, effective April 1, 2002. The motion carried. It was moved by Chairman Cramer to adopt resolutions banning the reintroduction of grizzly bear and wolves by the Forest Service. The motion died, due to lack of a second. The County Clerk was directed to forward the resolution to Kniffy Hamilton, Bridger-Teton Supervisor.
