OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
 MAY 7, 2002

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Bill Cramer, Betty Fear, Gordon Johnston, Mike McGinnis, Cat Urbigkit of the Sublette Examiner, Rob Shaul of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of April 19, 2002, were approved and ordered filed on motion by Commissioner Fear and seconded by Commissioner Johnston. The motion carried.

The official bond for Robin Clover, Director of the Sublette County Sexual Assault & Family Violence Task Force, in the amount of \$20,000, was approved and ordered filed with the County Treasurer.

A Viewer's Report was presented for the petition for abandonment of a road by Willis and Melissa McAmis. The Board reviewed the report and directed the County Clerk to advertise for the public hearing on June 4, 2002.

William Belveal presented a certified check in the amount of \$1,000 for the bond for the New Fork Willow Creek Road petition. Grant Beck stated his opposition to the petition and the County's involvement in the matter. Allen Davis and Willis McAmis stated their support for the petition.

Mike McGinnis, Road and Bridge Superintendent, reported that Chandler Peter of the Army Corps of Engineers will be here on May 13th to discuss the location of the proposed Industrial Site Road. McGinnis discussed contracting projects this summer, the use of enzymes on County roads, the need for a survey of the north end of the Paradise gravel pit, road maintenance on the Boulder Lake Road, and the well drilling at the Marbleton Landfill. Debris from Teton County trucks and at the Landfill was discussed. The May 9th meeting with Teton County was planned.

Tom Thompson of the Pinedale Sporting Clays Association, discussed the need for a survey for the BLM application for an additional 20 acres adjacent to the shooting range. It was moved by Commissioner Johnston and seconded by Commissioner Fear to hire Wilson Land Surveying for the project. The motion carried.

Mayor Rose Skinner and Barbara Boyce of the Pinedale Town Council, discussed 24-hour law enforcement coverage. It has been determined, due to activity in the County, that two additional officers would be required to cover all towns. The Board agreed to assist in funding the additional officers.

The applications for the County Commissioners Tuition Waiver Scholarships were reviewed. Two scholarships were awarded to Pinedale High School seniors, Gary Lankford and C.P. Saner. One scholarship was awarded to Big Piney High School
