The Board of County Commissioners met as the County Board of Equalization on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Cat Urbigkit of the Sublette Examiner, George Wilkes of the Pinedale Roundup, and Mary Lankford, County Clerk present. No protests were scheduled.

The Board recessed as the County Board of Equalization and will reconvene on June 24, 2002, to consider two protests. The Board convened as the Board of County Commissioners, in special session, for the purpose of FY03 budget preparation.

County Clerk Mary Lankford reviewed the IRS mileage rate, new legislation effecting law enforcement retirement contributions, and salaries.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
JUNE 4, 2002

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Bill Cramer, Gordon Johnston, Betty Fear, Cat Urbigkit of the Sublette Examiner, Joe Wilhelm of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of May 21, 2002, were approved and ordered filed on motion by Commissioner Johnston and seconded by Commissioner Fear. The motion carried.

In accordance with the public notice published in the Pinedale Roundup on May 16, 23, and 30, 2002, a public hearing was held for the abandonment of a road easement in Lot 2, McAmis Lot Division. There being no objections, it was moved by Commissioner Johnston and seconded by Commissioner Fear to abandon the easement. The motion carried.

Wayne and Kay Jensen and operators from the Jonah Field discussed obtaining a temporary easement for a road in the area of the Boulder South and Paradise Road. The property is owned by Doc Jensen and leased by Wayne and Kay Jensen. Mike McGinnis will contact Doc Jensen.

Lewis Gage complimented the Road and Bridge Department on the condition of the Boulder Lake Road and will followup with the Forest Service on a maintenance agreement for the road.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to adopt a Multi-County Grizzly Bear Resolution. The motion carried.

Mike McGinnis, Road and Bridge Superintendent, reported on rough road due to lack of moisture and the proposed soil stabilization project for Forty Rod County Road.
