

John Topper and Sue Wells discussed Sublette County's continued participation in the Yellowstone Development District. Topper informed the Board about the revolving loan fund and the benefits of membership to municipalities pursuing EDA funding for sewer projects. It was moved by Commissioner Johnston and seconded by Commissioner Fear to reappoint Paul Scherbel, Mary Lankford, Gordon Johnston, and appoint Tom Brown, Sue Wells, Will Hampton, and Rose Skinner to the YDD board. The motion carried, and the next meeting will be at Lakeside Lodge on September 27, 2002 at 11 a.m.

The Board accepted a resignation from Dan Holgate from the Sublette County Weed and Pest Board and will advertise for his replacement. The appointment will be made at the September 3rd meeting.

It was moved by Commissioner Johnston and seconded by Commissioner Fear to adopt Resolution No. 02-741C declaring Boulder Townsite County Road No. 23-227 a County Road. The motion carried.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to adopt Resolution No. 02-740C authorizing the Board to apply for a right of way, to be known as the Gros Ventre Alternate Route to the Paradise Road, and authorizing the Chairman to sign the application and other required documents. The motion carried.

Joan Mitchell of the Southwest Sublette Pioneers reported that the final estimate on the their building addition is \$356,558. The Board approved the request.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to approve and sign a Letter of Engagement with Mortenson, Stevens and Company, PC CPA, for the FY02 fiscal audit. The motion carried.

The Board discussed a proposal from Budd-Falen Law firm for council on RS2477 and the Erramouspe Road. Commissioner Johnston suggested grading the road. It was moved by Commissioner Fear and seconded by Chairman Cramer to retain the firm. The motion carried, with the vote being: Cramer-aye, Fear-aye, and Johnston-nay.

In accordance with the public notice published in the Sublette Examiner on July 18, 25, and August 1, 2002, public hearing was held for the establishment of an extension of the New Fork-Willow Creek County Road No. 23-120. Brad Clingman, County Viewer, presented his report to the Board and recommended against establishing the extension and suggested that the Board act as facilitators to provide access on Forest Service property and to include current land-locked properties in the area. Objections to the extension of the road were stated by John Blatt, David Smith, Ed Wardell, Mary Ann Moline, Dave Kanski, Jon Andrikopoulos, Jonita Sommers, John Walter, Dan Budd, Jim Noble, Walt Bousman, Jim Bousman, Van Huffman, and Doug Vickrey. Comments supporting the extension were made by William Belveal, Gina Pape Feltner, and Rick Kranz. It was moved by Commissioner Fear and seconded by Chairman Cramer to accept the viewer's report and recommendations. The motion carried, with the vote being: Cramer-aye, Fear-aye, and Johnston-nay. The Board thanked the public in attendance and advised Clingman to submit his expenses.

Doug Vickrey complimented the Road and Bridge Department on the completion of the Forty Rod Road project. Vickrey discussed parking and the snowmobile trail.
