

Mayor Rose Skinner, Patty Racich, Ron Brown, and Ed Wood, all representing the Town of Pinedale, discussed the proposed purchase of property from the Sublette Center and zoning and subdivision requirements.

It was moved by Commissioner Fear and seconded by Commissioner Johnston to authorize County Attorney Dale Aronson to present an offer of \$400,000 to the Sublette Center for the purchase of 4 acres, more or less, to be determined, and contingent upon required governmental approvals and subdivision. The motion carried.

Brad Waters recommended that the Board not sign the proposed contract from Hogan & Associates, due to the form of the contract, and request new forms. Bonding was discussed, and it was decided to review financial reports in lieu of bonding.
