

The Board discussed the required advertisement for delinquent audit reports by Special Districts. The Board directed the County Clerk to contact the Districts before advertising.

In accordance with the public notice published in the Sublette Examiner on November 28, 2002, public hearing was held for the following:

1. It was moved by Commissioner Fear and seconded by Commissioner Johnston to approve the conditional use permit application by John and Mary Kay Jensen to allow temporary storage of heavy equipment on 40 acres zoned A-1, located in Section 12, T31N, R109W, and Section 7, T31N, R108W, with the following conditions:

- Storage of all equipment, rigs, and materials shall be set back 300 feet from the Boulder South County Road No. 23-106.
- The site shall be kept neat and orderly to minimize visual impact.
- The conditional use permit shall expire five years from the approval of the County Commissioners.

The motion carried.

Chairman Cramer discussed attending the NACO conference in February 2003.

Diane Sakai, representing Tri-Town Recycling, reported that Debbie Morley had been appointed by the Town of LaBarge to the Joint Powers Board. Sakai discussed the expenses for the program, problems the Joint Powers Board is having, and the need to move to a more affordable site. The Board agreed.

The Board discussed a request with Jeff Trevillion of Devan Energy, conference call, to forgive \$27,547.68 in interest on taxes, which were reported in the wrong tax district. After discussion, it was moved by Commissioner Johnston and seconded by Commissioner Fear to approve the request and forgive the interest. The motion carried.

Mike McGinnis, Waste Management Supervisor, reported on a balefill, which produces round bales, in Lindon, Utah. McGinnis reported on difficulties with the BLM for the easement for power to the Marbleton Landfill. The Board discussed the issue with Prill Mecham, Area Manager, by conference call. McGinnis was directed to contact Bill Wadsworth at the BLM to resolve the situation.

The Board recessed the meeting for a conference call with John Erramouspe to discuss pending litigation.

The Board reconvened the meeting.

Commissioner Fear discussed the Ag. Center.
