It was moved by Commissioner Cramer to accept and act upon the recommendation of the Planning and Zoning Commission to amend the Zoning and Development Regulations Resolution to create a new zoning category for Large Tract Developments. The motion died, due to lack of a second and was tabled until the February 4th meeting.

Lance Koppenhafer and John Fear discussed the roof at the Ag. Center, and an outstanding bill from Spiegelberg. It was moved by Commissioner Cramer and seconded by Chairman Johnston to reappoint Lance Koppenhafer to the Ag. Center Committee.

The Board discussed continuing with a pilot program for Purchase of Development Rights with the PDR working group. Comments against continuing were received from Bob Harrower, John Mackey, Ed Wardell, and Karen Harrower. It was moved by Commissioner Cramer and seconded by Chairman Johnston to approve and budget for the continuation of the pilot project and reappoint Tom Davenport, Bernie Holz, Jo Crandall, and Nancy Espenscheid to the PDR Working Group. The motion carried.

County Treasurer Roxanna Jensen discussed signing a letter of disclosure and interest on taxes.

It was moved by Commissioner Cramer and seconded by Chairman Johnston to re-appoint Carl Robillard to the Sublette County Recreation Board for a five-year term. The motion carried.
