

Rick Hubbard, Communications Sergeant, presented two proposals for the E911 Dispatch Center equipment. The Board agreed to purchase the Motorola system for \$205,166.

It was moved by Commissioner Cramer and seconded by Commissioner Fear to adopt Resolution No. 03-765J amending the plat for Reardon County Road No. 23-139. The motion carried.

Paul Scherbel reported that he was working on the First North easements and an easement on Paradise County Road.

The Board reviewed the County Surveyor statutes with Scherbel. Scherbel presented a job description he had prepared in 1983. The Board referred the job description to the County Attorney. It was moved by Commissioner Cramer and seconded by Commissioner Fear to appoint Paul Scherbel to the position of County Surveyor for a term of one year commencing April 1st. The motion carried.

County Attorney Van Graham discussed road condemnation and advised the Board that it could condemn and assess the users, and easements may need to be purchased for the roadway.

Graham reported on an upcoming meeting at the Ag. Center and that he expects a preliminary response from the Attorney General regarding PDR's by April 15th.

The Board reviewed the County Sanitarian statutes with Keith Raney. It was moved by Commissioner Cramer and seconded by Commissioner Fear to appoint Raney to the position effective immediately until June 30th, then to commence for a term of four years, thereafter, effective July 1st. The motion carried. The Board requested a job description from Raney by June with recommended standards.

The Board discussed with Mike McGinnis, Waste Management Supervisor, a letter sent to trash haulers. The Board requested copies of all correspondence from his department. McGinnis reported that the Marbleton Landfill road needs work and that he had received a three and one-half page letter from DEQ regarding deficiencies from the February inspection of the Marbleton Landfill and Pinedale Transfer Station. McGinnis reported on the balefill tour on March 25th and informed the Board that the baler is portable and will be in Sublette County in July. McGinnis requested funding in the amount of \$9,700 for a household hazardous waste collection event. The Board approved the request later in the meeting.

The following petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: McMurry Oil Company, \$487.30; Phillips Petroleum Company, \$152.77; Ultra Resources, Inc., \$813.38; and Arnold Machinery, \$1,142.13.

Joel Bousman, representing various ranchers and land managers, discussed the County's participation in the 4C's Pilot Project, which would monitor Federal grazing allotments. The proposed pilot project area will include about 90,000 acres, at an estimated cost of \$2.00 per acre for the soil survey and ecological site inventory. The proposed area is Bureau of Land Management allotments held by permittees in the East Fork watershed. After discussion, it was moved by Commissioner Cramer and seconded by Commissioner Fear to support the concept of the pilot project and commit funding up to one-third of the project to a maximum of \$60,000. The motion carried.

Joan Mitchell, Director of the Southwest Sublette Pioneers, discussed unforeseen costs, due to Fire Marshall inspection, at their center, and requested an additional \$19,387.45. The Board approved the request.

Susan Kramer, representing Sublette Citizens for Recycling, discussed expanding the Recycling Center. The Board directed Kramer to obtain estimates for the work and submit them to the Board.

Brad Waters and Dan Holgate discussed the Senior Center fill material. It was decided to purchase it from Teletractors, Inc.

Waters reviewed the progress on the building projects with the Board.

It was moved by Commissioner Fear and seconded by Commissioner Cramer to appoint Bob Hanson to the position of Emergency Management Coordinator, while Tom Hueckstaedt is on active duty. The motion carried.

The Board approved and signed the Memorandum of Agreement with the Wyoming Emergency Management Agency.

The Board approved the contract with PacifiCorp. to extend the power service in the Sublette Golf Course Subdivision in Tee Circle.

County Clerk Mary Lankford reviewed the County insurance renewal and the insurance market. The Board approved the renewal with Tegeler & Associates in the amount of \$109,611.00.

The Board denied a voucher submitted by Surveyor Scherbel, Ltd.
