LOCATION CERTIFICATE AND NOTICE—LODE

NOTICE IS HEREBY GIVEN That FABAK Mining Co. 545

citizen S of the United States, over the age of twenty-one years, having discovered a mineral lead, lode, ledge, or vein, of quartz or other rock in place, or deposit, containing valuable minerals within the claim hereby located, claim by right of discovery and location all valuable minerals therein, including, without limiting the generality of the foregoing, all uranium and other valuable minerals or ores
