NOTICE IS HEREBY GIVEN, THAT THE UNDERSIGNED, having complied with the requirements of Section 2324 of the Revised Statutes of the United States, and the Local Laws, Customs and Regulations of this District, have located Fifteen Hundred feet in length by 600 feet in width, on this the Grey Back Lode, Vein or Deposit, bearing Gold, Silver and other precious minerals, situated in the Unorganized Mining District, Lincoln County, Wyoming, the location being described and marked on the ground as follows: to-wit:
