

LOCATION CERTIFICATE AND NOTICE-LODE

NOTICE IS HEREBY GIVEN That

William J. McCabe

citizen of the United States, over the age of twenty-one years, having discovered a mineral lead, lode, ledge, or vein, of quartz or other rock in place, or deposit, containing valuable minerals within the claim hereby located, claim by right of discovery and location all valuable minerals therein, including, without limiting the generality of the foregoing, all uranium minerals

under, and in accordance with, the laws of the United States and the State of Wyoming, 1500 feet horizontally along the vein or lode thereof, measured 750 feet N10°E and 750 feet S10°W from the center of the discovery shaft or discovery workings, and 300 feet in width on each side of the center of the discovery shaft or discovery workings, together with all dips, spurs, angles, variations, veins, leads, lodes, ledges and deposits. Said claim is situated in the unorganized Mining District in the County of Sublette, State of Wyoming, in the

this claim is either situated in section 30 or 31
and is adjoined by Elk Mt. #7 on the NW
and Elk Mt #5 on the NE.

The surface boundaries of said claim have been marked upon the ground with substantial monuments in the following manner, to-wit:

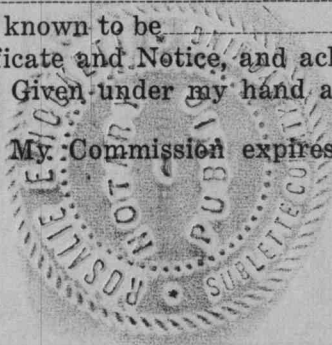
