

LOCATION CERTIFICATE AND NOTICE—LODE
NOTICE IS HEREBY GIVEN That William J. McCabe

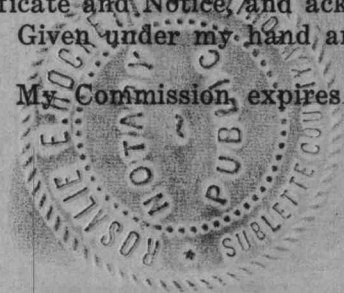
