

LOCATION CERTIFICATE AND NOTICE—LODE

NOTICE IS HEREBY GIVEN That William J. McCabe

citizen of the United States, over the age of twenty-one years, having discovered a mineral lead, lode, ledge, or vein, of quartz or other rock in place, or deposit, containing valuable minerals within the claim hereby located, claim S by right of discovery and location all valuable minerals therein, including, without limiting the generality of the foregoing, all uranium minerals
