

## LOCATION CERTIFICATE AND NOTICE — LODE

NOTICE IS HEREBY GIVEN That

*N. Braddock, J. L. Mincey, J. B. Thatcher, S. Nirth, J. K. Poorman, Gale O. Driscoll and A. A. Briggs*  
 citizens of the United States, over the age of twenty-one years, having discovered a mineral lead, lode, ledge, or vein, of quartz or other rock in place, or deposit, containing valuable minerals therein, including, without limiting the generality of the foregoing, all *uranium and other valuable minerals*

under, and in accordance with, the laws of the United States and the State of Wyoming, *1500 ft*  
 feet horizontally along the vein or lode thereof, measured *750* feet *East* and *750* feet  
*West* from the center of the discovery shaft or discovery workings, and *600* feet in width
