

LOCATION CERTIFICATE AND NOTICE — LODE

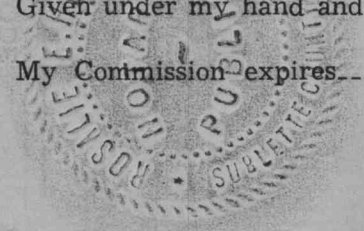
