THAT THE NAME of this claim is PARD #2

THAT THE LOCATOR(S) of this claim (is) (are) the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 747 feet in a East direction and 753 feet in a West direction and in width, 300 feet in a North direction and 300 feet in a South direction, comprising in all 1500 feet in length and 600 feet in width.
