

LOCATION CERTIFICATE AND NOTICE—LODE

NOTICE IS HEREBY GIVEN That Wm. J. McCabe

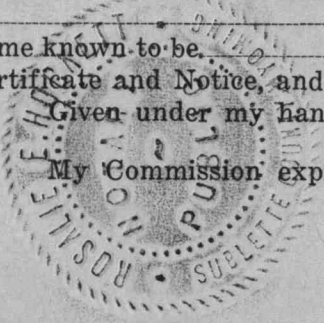
