

LOCATION CERTIFICATE AND NOTICE — LODE

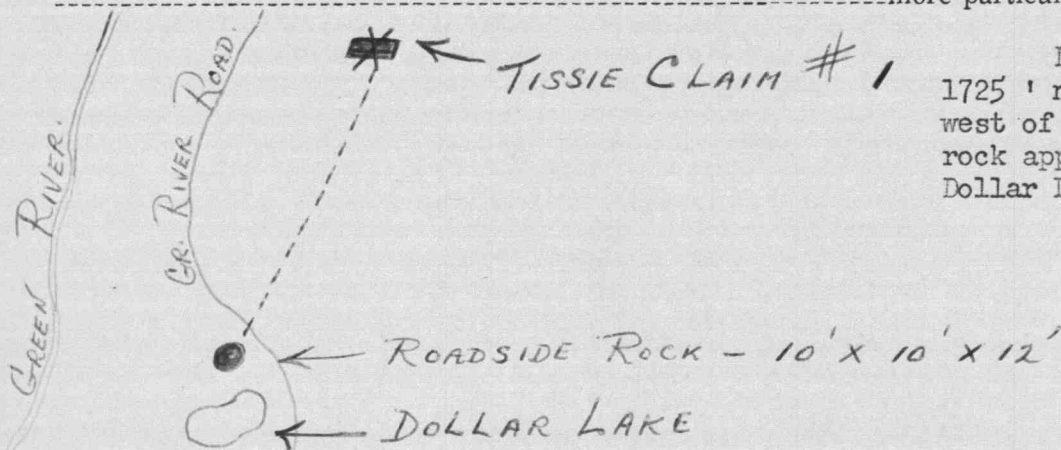
NOTICE IS HEREBY GIVEN That Dr. & Mrs. John G. Cecil,
