

## LOCATION CERTIFICATE AND NOTICE — LODE

NOTICE IS HEREBY GIVEN That Clayton Gaddes, who is a

citizen of the United States, over the age of twenty-one years, having discovered a mineral lead, lode, ledge, or vein, of quartz or other rock in place, or deposit, containing valuable minerals therein, including, without limiting the generality of the foregoing, all Gold, Silver, Cobalt, Lithium, and all other metals and minerals
