LOCATION CERTIFICATE AND NOTICE — LODE

NOTICE IS HEREBY GIVEN That Art Thoe

citizen of the United States, over the age of twenty-one years, having discovered a mineral lead, lode, ledge, or vein, of quartz or other rock in place, or deposit, containing valuable minerals therein, including, without limiting the generality of the foregoing, all gold and silver and all other minerals

under, and in accordance with, the laws of the United States and the State of Wyoming, 1500 feet horizontally along the vein or lode thereof, measured 750 feet East and 750 feet West from the center of the discovery shaft or discovery workings, and 300 feet in width on each side of the center of the discovery shaft or discovery workings, together with all dips, spurs, angles, variations, veins, leads, lodes, ledges and deposits. Said claim is situated in Sublette Mining District in the County of Sublette, State of Wyoming, in the

Upper Green River Drainage Area, in Sections 25, 26, and 35, Township 39 North, Range 109 West, 6th Principal Meridian, Wyoming

more particularly described as follows, to-wit:

Beginning at a point which is the head of Gypsum Creek Canyon, thence East 3000 feet, thence South 300 feet to the point of beginning, which is the Northwest Corner of this claim, being Corner No. 1, thence East 1500 feet to Corner No. 2, being the Northeast Corner, thence South 600 feet to Corner No. 3, being the Southeast Corner of this claim, thence West 1500 feet to Corner No. 4, being the Southwest Corner, thence North 600 feet to the point of beginning, lying due East and adjoining Green River Lode No. 4.
