

LOCATION CERTIFICATE AND NOTICE - LODE

NOTICE IS HEREBY GIVEN That JAMES COLLINS, TRAVIS HENDRICKS,
JEAN H. SPENCER, B.H. VANDEGRIFF

citizens of the United States, over the age of twenty-one years, having discovered a mineral lead, lode, ledge, or vein, of quartz or other rock in place, or deposit, containing valuable minerals therein, including, without limiting the generality of the foregoing, all GOLD, SILVER, COPPER, ZINC, LEAD, BERYL, BARITE, CINNABAR AND ALL OTHER MINERALS under, and in accordance with, the laws of the United States and the State of Wyoming, 1500 feet horizontally along the vein or lode thereof, measured 300 feet SOUTHWEST and 300 feet NORTHEAST from the center of the discovery shaft or discovery workings, and 750 feet in width on each side of the center of the discovery shaft or discovery workings, together with all dips, spurs, angles, variations, veins, leads, lodes, ledges and deposits. BEGINNING AT A POINT WHICH IS THE SOUTHERN END OF HOBACK BRIDGE AT BATTLE MOUNTAIN THENCE 961 FEET (361 FT. NW THEN 600 FT. SW RESPECTIVELY) TO CORNER NO. 1 WHICH IS THE SOUTHEAST CORNER OF THIS CLAIM, THENCE 1500 FT. TO CORNER NO. 2 WHICH IS THE NORTHWEST CORNER OF THIS CLAIM, THENCE 600 FT. TO CORNER NO. 3 WHICH IS THE SOUTHWEST CORNER OF THIS CLAIM, THENCE 600 FT. TO THE POINT OF BEGINNING.

On the surface at the point of discovery a plain notice has been posted containing the name of the lode or claim, the name S of the discoverer S and locator S, and the date of such discovery.
