POWER OF ATTORNEY
FIDELITY & DEPOSIT CO. OF MARYLAND TO O. H. BROWN & B. M. AUSHERMAN

KNOW ALL MEN BY THESE PRESENTS: That the FIDELITY AND DEPOSIT COMPANY OF MARYLAND, by JOHN H. WIGHT its Vice-President and EDGAR F. DOBSON its Assistant Secretary, in pursuance of Authority granted by Section 3, Article VI, of the By-Laws of said Company, a copy of which Section is hereto attached, does hereby nominate, constitute and appoint B. M. Ausherman and O. H. Brown, both of the City of Evanston, State of Wyoming, its true and lawful agents and attorneys in fact, to make execute, seal and deliver for and on its behalf as surety, and as its act and deed bonds or undertakings of suretyship in penalties not exceeding the sum of One hundred thousand dollars (\$100,000) each for Executors, Administrators, Receivers, Assignees and Commissioners for the sale of property required to be given by Order or Decree of any County of the State of Wyoming, or in the United States Circuit or District Courts for said state, and for Trustees and Receivers in Bankruptcy proceeding under the Bankrupt Act of the United States. Also, bonds, in penalties not exceeding the sum of Ten thousand dollars (\$10,000) each, required, of state, County, township, or Municipal Officials in the State of Wyoming, whether elected or appointed.

Such bonds to be signed for the Company by said B. M. Ausherman, as attorney-in-fact, and attested, as agent, and the seal of the Company affixed by said O. H. Brown. And the execution of such bonds or undertakings in pursuance of these presents, shall be as binding upon said Company as fully and amply, to all intents and purposes, as if they had been duly executed and acknowledged by the regularly elected officers of the Company at its office in Baltimore, Maryland, in their own proper persons. This power of Attorney revokes that issued November, 22nd 1910, in behalf of B. M. Ausherman and J. W. Carse.
