POWER OF ATTORNEY
HUGH THORNTON AND PETER THORNTON TO GEORGE THORNTON

KNOW ALL MEN BY THESE PRESENTS: That Hugh Thornton and Peter Thornton, brothers of Rody Thornton, deceased, of Mt. Sterling, Illinois, have made, constituted and appointed, and by these presents do make, constitute and appoint George Thornton, also a brother of the said Rody Thornton, deceased our true and lawfully attorney for us and in our name, place and stead to act for us, and each of us, in all matters pertaining or relating, in any manner whatsoever, to the estate of Rody Thornton, deceased, late of Uinta County, Wyoming, hereby expressly giving and granting to our said attorney full, power and authority to waive all notices, make any compromise, sell and convey any or all real and personal property of said estate, agree to any and all settlements with the administrator, the heirs or other parties, to receive our and each of our portion of the distribution and to give receipts for our distributive shares, and to execute and deliver any and all deeds or other instruments necessary or convenient to vest such property in any person or persons and with full power and authority to mortgage and encumber the same, and in general to do all acts and things that we, or either of us, might or could do in and about the administration of said estate and the sale and vesting of our rights, titles, interests and estates in property of said estate in any other person or persons as to our said attorney shall appear proper.

Giving and granting unto our said attorney full power and authority to do and perform all and every act and thing whatsoever requisit and necessary to be done in and about the premises as fully, to all intents and purposes as we, or either of us, might or could do if personally present at the doing thereof, hereby ratifying and confirming all our said attorney shall lawfully do or cause to be done by virtue thereof.
