Also to acquire Real and Personal Property, to buy and sell the same. Said company shall have the power to enter into contracts, or agreements respecting all of its property of for carrying out the purpose hereof. Which any natural person may lawfully enter into and which is not prohibited by law respecting corporations and in a general way to do and perform all things necessary or essential to the proper management controle and operation of its business and all things incident and appurtenant thereto. The amount of its capital stock is \$5000.00, divided into 200 shares at the par value of \$25.00 each. The term of its existance shall be fifty years. The number of directors for the first year shall be five and there names are, W. G. Heitz, H. B. Thompson, J. A. Black, J. B. Budd, James Micelson. CERTIFICATE OF ARTICLES OF ASSOCIATION OF STATE BANK OF BIG PINEY.

KNOW ALL MEN BY THESE PRESENTS: THAT, P. J. Quealy, A. Kendall, A. H. Marble, Frank Pfeiffer, and J. P. Boyer, all citizens of the United States and all residents of the State of Wyoming do hereby accociate themselves together and do hereby form a company for the purpose of carrying on a general banking gusiness in the village of Big Piney, in Lincoln County, Wyoming, subject, however, to the contingencies, restrictions, conditions and liabilities prescribed in Chapter 269 of the 1910 Wyoming Compiled Statutes, and for such purpose they do hereby make, execute and acknowledged according to law, in triplicate, this certificate of articles of association, and do hereby certify that state as follows, to wit: First. The corporate name of this company is "State Bank of Big Piney."

Second.

The object for which this company is formed is to carry on a general banking business.

Third.

The term of existence is fifty years ^{FRONT} and after the date of filing this certificate in the office of the Secretary of State of Wyoming.

Fourth

The place where its offices shall be located and its operations are to be carried on is in the village of Big Piney, in Lincoln County, State of Wyoming.

Fifth

The amount of its capital stock is ten thousand dollars divided into one hundred shares of par value of one hundred dollars each.
