Certificate of Incorporation of the Blyth and Fargo Company.

We whose names are hereunto subscribed desiring to form a Company under and by virtue of the Statute in such case made and provided for the purposes hereinafter mentioned do hereby certify.

1.

The Corporate name of said Company shall be the Blyth and Fargo Company.

II.

The objects for which the said Company is formed are the carrying on of the merchandising business in all its branches both by wholesale and retail, The purchase, sale, lease, and improvement of all kinds of real and personal property for profit or otherwise including the power to mortgage or otherwise incumber the same or any part thereof for the purpose of a security or securities thereon and including also the power to take security by mortgage or otherwise upon any real or personal property for the purpose of securing the payment of any indebtedness due to the said Company including also the power to pledge any of its property as a security and to take a pledge of any property for the purpose of security. This Company shall also have power to purchase hold and own any stock and to any amount in any other Company that may be subsidiary or tributary to and that does contribute to the objects and purposes of this Company. This Company shall also have power to borrow money in any sum or sums and to give therefore its notes, bonds, debentures or other evidence of its indebtedness and to give a mortgage or other forms of security upon the purchaser or any of its property, to secure the payment thereof. This Company shall also have power to enter into any contract or agreement in respect to any of its property which a natural person might enter into and which is not prohibited by law in respect to Corporations. The further object of this Company shall be the carrying on of any kind of manufacturing, including all the incidental powers necessary to the carrying on of the same. The further object of this Company shall be the establishment and operation of any transportation and express business and to charge and collect reasonable tolls and compensation for any service or duty performed in the line of such business.

This Company shall also have power to enter into any contract or contracts with any party or parties for the improvement, development and cultivation of any lands and tenements.

III.

The amount of the capital stock of the said Company shall be One hundred and Fifty Thousand Dollars (\$150,000).

IV.

The term of the existence of the said Company shall be Fifty years.
