Notice of Location of a Quartz Claim. Notice is hereby given to all whom it may concern That, I, B. E. Wilcox and L. G. Christie and -----citizens of the United States, over the age of twenty-one years, having discovered a vein or lode of quartz, or rock in place, bearing (gold) within the limits of the claim hereby located, have this day, under and in accordance of the Revised Statutes of the United States, chap.
