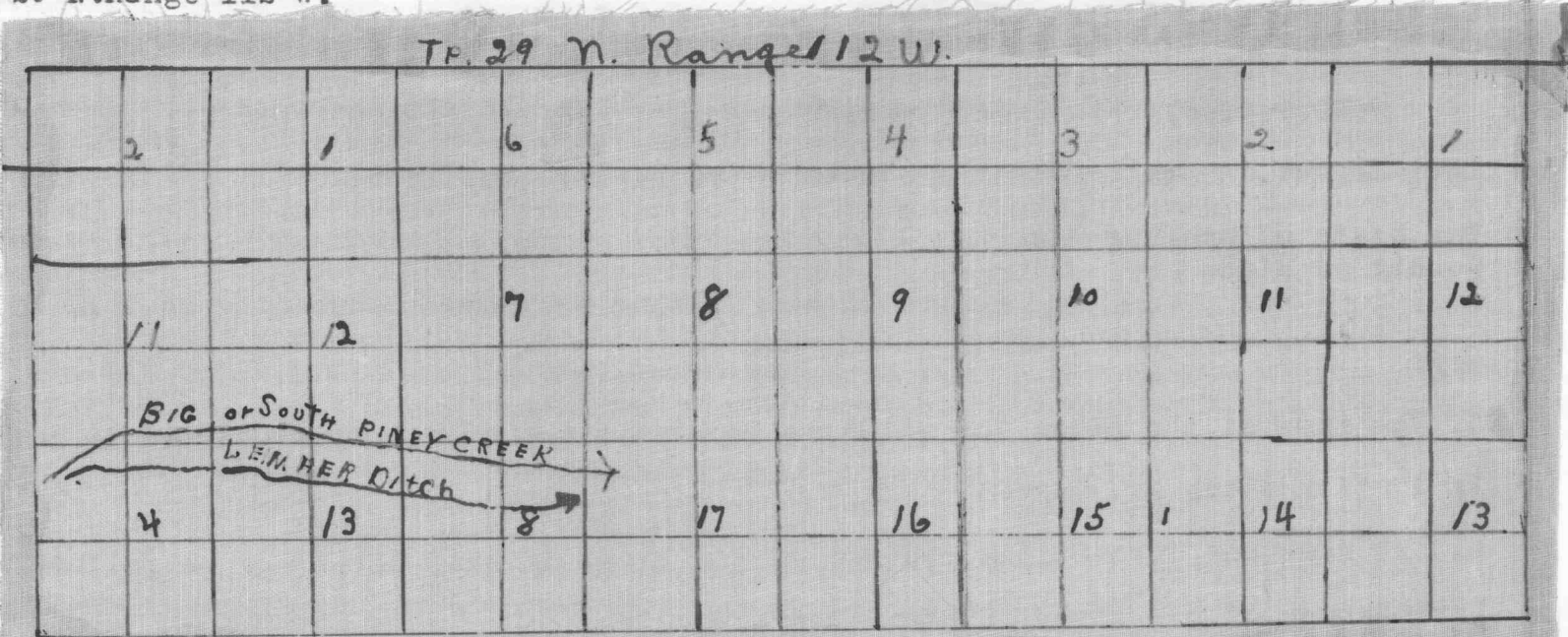

No. 1672. Quit Claim Deed.  
N. S. Miller "to" Hedwig E. Miller.  
This indenture, Made this 11th day of April, in the year of our Lord One Thousand  
Eight Hundred and Ninety three, Between N. S. Miller of La Barge, Uinta County, Wyoming  
of the first part, and Hedwig E. Miller of LaBarge, Uinta County Wyo of the second part.  
Witnesseth, That the said party of thefirst part, for and in consideration of the sum of  
One Dollar and other good and lawful considerations to the said party of the first part  
in hand paid by the party of the second part, the receipt whereof is hereby confessed and  
acknowledged, have granted, bargained, sold and quit-claimed, and by these presents do grant,  
bargain, sell and quit-claim, unto the said party of the second part, her heirs and assigns  
forever, all the following described lot or parcel of land, situate, lying and being in the  
County of Uinta and State of Wyiming to wit: An undivided one-fifth (1/5) interest in and to  
the irrigation ditch known and recorded as the Riverside irrigation ditch, situate on the  
west side of Green River and drawing water therefrom.  
To Have and to Hold the same, together with all and singular the appurtenances and privileges  
thereunto belonging, or in anywise thereunto appertaining, and all the estate, right, title,  
interest and claim whatsoever, of the said party of thefirst part, either in law or equity,  
to the only proper use, benefit and behoof of the said party of the second part, her heirs  
and assigns forever.
