Now Know Ye, that the Board of Control, under the provisions of Division 1, Title 9 Chapters 10 and 14 of the Revised Statutes of Wyoming, 1899, has, by an order duly made Nov. 28, 1902 and entered on the 17th day of April, A. D. 1903, in Order Record No. 3, Page 97, determined and established the priority and amount of such appropriation as follows:

The right to water hereby confirmed and established is limited to irrigation and the use is restricted to the place where acquired and to the purpose for which acquired; rights for irrigation not to exceed one cubic foot per second for each seventy acres of land for which appropriation is herein determined and established.
