Whereas, C. T. Davis and J. P. McCarter has presented to the Board of Control of the State of Wyoming proof of the appropriation of Water from North Beaver Trib. to Green River through the Davis and McCarter Ditch under Permit No. 1521 for irrigation of the lands herein described, lying and being in Uinta County Wyoming and for irrigation.

Now Know Ye, That the Board of Control under provisions of Divisions 1, Title 9, Chapters 10 and 14 of the Revised Statutes of Wyoming, 1899, has, by an order duly made Nov. 28, 1902 and entered on the 17th day of April, A. D. 1903, in Order Record No. 3, Page 97, determined and established the priority and amount of such appropriation as follows:

McCarter; Postoffice address Pearl, Wyoming, General Priority number on main stream: 115; Priority number on North Beaver 2 Amount of Appropriation, 2.65 cu. ft. per sec; Date of Appropriation July 2nd 1897; Description of land to be irrigated, and for which this appropriation is determined and established-- One hundred and Eighty four (184) acres. Being Eight (8) acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$ Twenty five (25) acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$ Five (5) acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$; Twenty five (25) acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$ Sec. Thirteen (13) Forty (40) acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$ Thirty six (36) in NW $\frac{1}{4}$ NW $\frac{1}{4}$ Ten acres (10) in SW $\frac{1}{4}$ NW $\frac{1}{4}$ Thirty five (35) acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$ Sec. Twenty four (24) T. 36 N. R. 112 W.

The right to water hereby confirmed and established is limited to irrigation and the use is restricted to the place where acquired and to the purpose for which acquired; rights for irrigation not to exceed one cubic foot per second for each seventy acres of land for which appropriation is herein determined and established.

In Testimony Whereof, I, Fred Bond, President of the State Board of Control, have hereunto set my hand this 28 day of May, A. D. 1903, and caused the seal of said Board to be hereunto affixed.
