Whereas, Thomas Odle, has presented to the Board of Control of the State of Wyoming, proof  
of the appropriation of water from Horse Creek Trib. to Green River through the Anderson  
Ditch under permit No. 353 enlg. for irrigation of the lands herein described, lying and  
being in Uinta County, Wyoming and for irrigation.

Now Know Ye, that the Board of Control, under the provisions of Division 1, Title 9,  
Chapters 10 and 14, of the Revised Statutes of Wyoming, 1899, has by an order duly made  
Nov. 28-1903 and entered on the 17th day of April, A. D. 1903, in order Record No. 3, Page  
101, determined and established the priority and amount of such appropriation as follows:
