Now Know Ye, that the Board of Control, under the provisions of Division 1, Title 9, Chapters 10 and 14 of the Revised Statutes of Wyoming, 1899, has by an order duly made Nov. 28, 1902 and entered on the 17th day of April A. D. 1903 in Order Record No. 3, page 86, determined and established the priority and amount of such appropriation as follows: Name of Appropriator Z. T. Noble ; Postoffice Address Big Piney Wyoming; General Priority Number on main stream; 86; Priority Number on Middle Piney 11 Amount of Appropriation, 2.28 cu. ft. per sec.; Date of Appropriation July 27, 1893. Description of land to be irrigated and for which this appropriation is determined and established; One hundred & Sixty (160) acres; Being Eighty (80) acres in S 1/2 NE 1/4 Eighty (80) acres in S 1/2 NW 1/4 Sec. Eleven (11) T. 29. N. R. 113 W.

The right to water hereby confirmed and established is limited to irrigation and the use is restricted to the place where acquired and to the purpose for which acquired; rights for irrigation not to exceed one cubic foot per second for each seventy acres of land for which appropriation is herein determined and established.
