Ditch under Permit No.----for irrigation of the lands herein described, lying and being in Uinta County Wyoming, and for irrigation.

Now Know Ye, that the Board of Control, under the provisions of Division 1, Title 9, Chapters 10 and 14 of the Revised Statutes of Wyoming, 1899, has by an order duly made Nov. 28, 1902 and entered on the 17th day of April, A. D. 1903, in Order Record No. 3, page 91 determined and established the priority and amount of such appropriation as follows: Name of Appropriator Jas. Jenson; Postoffice Address Big Piney Wyoming. General Priority Number on main stream 70; Priority Number on South Piney 11; Amount of Appropriation, .57 cu. ft. per sec.; Date of Appropriation June 1889; Description of land to be irrigated, and for which this appropriation is determined and established. Thirty eight (38) acres---Being Six (6) acres in SE $\frac{1}{4}$ SW $\frac{1}{4}$ Eight (8) acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. eleven (11) Eight (8) acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$; Sixteen acres (16) in NE $\frac{1}{4}$ NW $\frac{1}{4}$ Sec. Fourteen (14) T 29 N. R. 113 W.

The right to water hereby confirmed and established is limited to irrigation and the use is restricted to the place where acquired and to the purpose for which acquired; rights for irrigation not to exceed one cubic foot per second for each seventy acres of land for which appropriation is herein determined and established.
